USA FAA to Indian DGCA license conversion training in India Flight training 20 hours (aircraft and simulator)	Approximately 16 weeks
Multi Pilot Training - MCC, Jet Handling, A320 Type Rating	Approximately 8 weeks

Note: On successful completion of the USA FAA training, you will return to India to complete your USA FAA conversion (to Indian DGCA) at a DGCA approved training facility. Successful completion of this phase will lead to the issue of an Indian DGCA MECPL/IR.



Finance & Funding

- > DGCA Ground School USD\$5,500 (covers all 3 DGCA exams)
- > FAA Flight training USD \$86,000
- DGCA License conversion fly portion – USD\$4,500 to \$7,000
- > MCC/A320 Type Rating USD\$39,000
- > Total Training Fee USD \$135,000 \$137,500

What's included

- > Regulatory exam and skills test fees*
- Initial USA FAA and Indian DGCA conversion CPL/MEIR License issue fee

To apply for the L3Harris Airline Academy IndiGo Cadet Pilot Program you must meet the following requirements:

- > Must be between 18 and 32 years of age
- Have a valid passport and the unrestricted right to live and work in India, with the ability to travel unrestricted worldwide
- > Fluent in English (verbal and written)
- Able to produce a Criminal Record Check (CRC) Basic Disclosure Certificate and pass all IndiGo referencing checks
- Able to obtain and maintain Indian DGCA and FAA Class 1 Medical Certificate
- Must have access to the full funding required for this course**

Academic Entry Standards

Minimum Education Qualification: 10+2 with minimum score of 51% / Grade Point 6 / Grade C1 – Individually in each subject i.e. Physics / Mathematics / English or a Higher Degree in these subjects with minimum of 51%.

NOTE: Prior to your induction training with IndiGo you will be required to pass a drug test.
